<b>Reports:</b>  <u>Hospitals</u>  HCA- Tri-Cities/John Randolph	Ashley Hansen reported that TPA rates have been very good all within 60 minutes for both facilities. They are pursuing process improvement including ways to transfer patients to thrombectomy capable facilities. Their intention is to fly all stroke as primary policy. They are in discussion about JRMC's helipad saying that they are looking at other options but have nothing concrete right now. Tri-Cities is pursuing Acute Stroke Ready certification. Tri-Cities is doing really well for patient loads seeing 70-80 patients a day.

<p>Bon Secours</p>	<p>Evelyn Dickey-White reported for all Bon Secours facilities. Door to needle time of less than 60 minutes was met 50% of the time. Evelyn reported that 41 patients were treated between June to August. Teleneurology reperfusion rates for the whole system was 36 %. St. Mary's Hospital was 31%. MRMC was 17%. Saint Francis was 21%. A new nurse practitioner started in July at Richmond Community tied to a hypertension clinic. She reported also that Richmond Community and Memorial Regional are in a window for site visits from the Joint Commission. St. Mary's will likely have their Joint Commission visit in the beginning of 2018. She reported that Bon Secours is excited about the EMS expo hosted with Henrico Fire coming March 3-4, 2018 with a registered 705 participants. Lastly, she introduced Dr. Loy for St. Mary's Hospital as a new radiologist on staff.</p>

They are also improving staffing. The patient had had a mitral valve replacement which was the assumed etiology. The other significant part was that Chesapeake EMS brought their metrics for stroke and it was very impressive. She reports that they are willing to bring their presentation to the committee. It was decided that it would be beneficial for PI committee members to be invited to the next Stroke Committee meeting for a presentation of the data.</p>
