| Mission Lifeline | John Dugan lets the group know that the application period for the EMS awards has been extended to the end of March. VHAC will have its annual meeting on May 29 th in Lynchburg. Topics will include Mission Lifeline STEMI, Mission Lifeline Stroke, and Mission Lifeline Resuscitation. John lets us know that the format of the reports will be changing, and that Dr. Kontos is sitting on that committee, before beginning the Q3 data presentation. As a region, we have 64% of STEMIs arriving by EMS, same as the state. Our median times are consistent. Our times for first medical contact to PCI (80.5 minutes) is better than the state, which increased from 81 minutes to 85 minutes. There was some concern that we were not consistently doing an ECG within 10 minutes of arriving at the ED; John said there may be several at 11 or 12 minutes, which would affect this data. He also suggests trying to get the 75% percentile of the door-to-balloon time under 60 minutes. The group agrees that our times have been consistent and that that is due in large part to the STEMI Steering Committee. | |
| STEMI Guidelines | The group reviews that STEMI guidelines that were distributed, and makes the following suggestions: -Section 1.1 – “within 10 minutes of patient contact” -Section 1.3.3 – Activation can be based on ECG readout or identification of ST elevation by provider interpretation, monitor interpretation, or transmission. | |
