VCU Medical Center	<p>Jay Gould – several ALS classes starting in the area at the ODEMSA office and the Crater Criminal Justice Center. All together, VCU has about 90 students in the pipeline. Roa Ivatury Trauma Symposium in March. Fred Parker award is open for nominations.</p> <p>Kelley – Doing 3 EPC courses in the area coming up. ENPC courses offered at VCU as well.</p> <p>Beth – five more TNCC, ANTC, and TCAR (Henrico Training Center). Had site review by ACS for trauma verification. Recruiting for three trauma surgeons and another trauma registrar.</p>	
Air Medical	<p>Devon Clary – met early February. Project for all the HEMS providers in the state to work in a STEMI project. Working to update the ODEMSA Medivac guidelines</p>	
Medical Control	<p>Dr. Allen Yee – Switching from prednisone to dexamethasone for the ability to be able to administer to pediatric patients. Change from D50 to D10 for less complications. Discussed Cyanokits – looking at the possibility of a grant to be able to purchase kits. Talked about challenges with DEA regulations and giving analgesics. Updating RSI guidelines.</p>

<p>New Business:</p> <p>Three committees or Two committees?</p> <p>Committee makeup</p>	<p>New Committee Structure: Brian McCray sent out information to the committee chairs with template policy and procedures (Appendix A) for each committee to consider and adopt. Included is the committee make-up. This has to be reconciled with the language in the contract (Appendix B).</p> <p>Beth: The contract with the state is not completely clear. PI as Medical and Trauma committee. Does not define 3 independent committees. Can we incorporate the Trauma Triage committee into the Trauma PI committee? The contract does mentions three, but is vague about the implementation. General agreement about switching to two committee meetings if allowed by the state.</p> <p>Heidi – The contract is very specific about the Trauma PI and Medical PI committees. Gave some historical background on the Trauma Triage, in that a third Trauma Triage committee was needed as a separate committee at the time to work on a new document/procedure.</p> <p>Discussion about the makeup of the PI Committee, which will be adopted for both or all three once finalized. After much discussion, the group was in general agreement about the following makeup:</p> <p>Planning District reps – 4 members (primary and alternate for each)</p>	<p>Heidi and Adam to meet with Paul Sharpe to clarify the contract language regarding the makeup of the committees.</p> <p>The chairs to meet to finalize the structure to give a final product for vote at next PI</p>
