<p>New Business: <u>Recent MCIs/Exercises</u></p>	<p>CVHC states have had a couple of smaller MCI's that didn't require a regional response; most have been approx. 5-8 patients but everything else has been going well on this side; RAA mentioned a discussion years ago about having a "Triage Tuesday/Thursday", and have implemented MCI drills in their new employee orientation; is this a good opportunity to revive this topic as a region? Ken stated the last time he heard of this initiative was in the hands of the Chiefs' Council; Ken and Bubby would like to move forward with a plan through this committee; Al mentioned that there was a discussion involving the state on what triage plan was going to be used but wants to consider a couple of times of year, using the HEAR radio on a pre-determined day to transmit reports; Bubby stated that with the state MCI committee, integrated some of the SALT triage into the program and rely on the jurisdictions to decide whether they will use SALT or START triage Steve Parrott made a reminder to the committee that they could use the Patient Distribution phone number that is listed in the plan, and the number will take them directly to the VCU comm or whomever is in charge of patient distribution at the time of an incident; there is a chance you might see the old number, but the new number is 800-276-0683; Ken would like for the group to look at creating a sub-committee to put together a plan for a tentative "Triage Tuesday"; Bubby will reach out to Ken prior to the next meeting to determine what they want to do and garner interest</p>
