Bon Secours	Have noticed an increase with a lot of incomplete PCR's; SFMC advised experiencing a shortage of duo-nebs and may have to reduce the amount of nebs currently in box until stock is sufficient; advised to put an alert on the box if duo-nebs aren't in box; Bon Secours facilities have also begun placing racemic epinephrine in the boxes; it was stated that the drug box schematic, in the upper tray on the left side of the box, showed Zofran as ODT instead of vial; advised that it had been updated; Tarsha will also double check to make sure ketamine is no longer on list of meds in box; it was also stated that providers are continuing to try to exchange expired boxes at FSED's; due to limited supply	

and limited availability of pharmacists at these facilities, they will not be exchanged; Tarsha will send out a notice to agencies to remind providers to go	
to main facilities to swap boxes

Sentara Williamsburg	Received a box approx. a month ago that was used outside of ODEMSA and the patient was taken to Riverside; Tarsha advised spoke with both Riverside and the provider; Riverside advised that they replace any used meds on site with the provider, then reseal; Riverside restocked the medic (a cardiac drug) but did not open narcotics kit to verify; provider returned box to Sentara Williamsburg where the narcotics were accounted for, and the box resealed; the question was what should the facility do when this happens again; I stated that I advised the crew to bring the box back to an ODEMSA facility and committee agreed; committee also stated that if there is any usage or waste of narcotics, to have that done with the facility they're transporting to, and to make sure the provider obtain the names and signatures of the MD and nurse/pharmacist who wasted/accounted for meds, then return the box to an ODEMSA facility to be restocked/resealed

New Business:  Business from the Floor	Roster – Tarsha advised had been updating roster whenever told of any changes, but wanted to make sure it was as up-to-date as possible; during roll call, Tarsha and Carrie went through and updated the facilities' voting representation  Drug Box Inserts – Tarsha went to Southside Medical Center to repair a box, and was advised that with the new square boxes in the narcotics box (instead of the long rectangular one) that some meds may be packaged as a syringe and don't fit; committee was in unanimous agreement that they liked the boxes and wanted them to stay, but stated would be ok with a facility removing ONE of the square boxes when a syringe needs to be stocked instead of a vial Drug Box Seals – ODEMSA no longer has any of the flat yellow seals; all facilities should have the new seals, either delivered by me or their respective EMS liaison; please use the old flat seals until your supply has been exhausted, then can use the new seals on any box that doesn't have a grommet; Tarsha is working with Ryan to schedule dates with pharmacies to have grommets placed and to replace torn sleeves	Motion: Seconded: Vote:
