VHAC/VCSQI	VHAC/VCSQI will be hosting their next meeting in Richmond 10/8-10/9 with Dr. Sinha as a keynote speaker; there will be more EMS content; all 5 clinical work groups are up and running (cardiogenic shock, thrombolytics, pulmonary embolus, EMS education and ED bypass/direct to cath lab); there has been a protocol developed for cardiogenic shock for the state, a slide deck for teaching ECG's to EMS and finalizing a protocol for bypassing the ED for STEMI patients; would like for anyone who is able to please get involved with VHAC and to attend the next meeting; Megan Vaughn emphasized that the data is anonymized and encourages every hospital system to join; advised that the most basic metric that's being followed is MI because every patient categorized under this metric is included unless an intervention wasn't done, so it helps to compare "apples to apples" amongst facilities, and helps to influence care across the region, with the ultimate goal of improving reperfusion times
